## THE SOUP KITCHEN WORKS BECAUSE

The Soup Kitchen works because everyone helps. Volunteers, donors, and guests. It sounds simple, but it isn't. Restaurateurs tell us that it is impossible to staff a restaurant kitchen with volunteers. The Soup Kitchen has done that for over 38 years. Volunteers contribute about \$500,000 of labor every year, and are vital to our success.

The key to financial success is you, our donors. You contribute 70% of our budget every year, year in and year out. Other pieces fluctuate. We have improved our event receipts. We run a tight budget. We have found corporate donors who fund food for the poor. These improvements add up to a 10% increase.

Guests help as much as they can. They clear their trays every day, and some volunteer. A few leave small donations in the "tip" jar.

On the negative side, we have lost 2 or 3 supporting groups every year for the last 3 years. Supporting groups (church and business) bring the food as well as the volunteers, so our food costs are up. Federal support for food programs is 1/6 what it was 10 years ago. Our

regular volunteer groups from companies have also become fewer. Matching gifts are down. The losses are about 20%.

Our guests have increased needs. The SNAP program (food stamps) of 10 years ago gave a single person \$200 in benefits. SNAP has been reduced several times. That same person now receives \$16. That is why we are distributing more food in the dining room along with the daily meal.

The bottom line is that we have run \$10,000 in the red every year for the past 4 years. Don't get excited, we are not in danger. But as the caretakers of this corporation, we must reverse this trend.

For that, we need your help. Can you dig a little deeper? Can you recommend the Soup Kitchen to your service group? Do you know people who might donate? No matter how hard we try, we will never eliminate the need for the Soup Kitchen. We need your help to keep The Soup Kitchen healthy for those who will need it now and in the future.

#### WHO PACKED THE PARACHUTE?



Charles Plumb was a Navy pilot in Vietnam. On his last mission, he was shot down by a missile. He spent 6 years in a Vietnamese prison, and he lived to tell the story.

### **MATCHING GIFTS PROGRAMS**

The Whirlpool Corporation matching gift program matches personal contributions of \$50 and up with dollars from the Whirlpool Foundation. Full-time, salaried and hourly U.S. Whirlpool employees and retirees are eligible. Please, if you are eligible for matching gifts, please take that opportunity. Private foundations must distribute five percent of the value of their net investment assets annually. As for most things involving the IRS, it is a bit more complicated than that, but 5% is close. So you are not imposing by requesting a matching gift. You are helping to direct money that they must donate. ## EQUITY GIFTING AND THE RMD CHARITABLE DEDUCTION

The strong performance of the stock market the last several years has left many investors with appreciated stock which will result in a capital gain when sold by the owner. Gifting appreciated stock is one of the most effective means of tax savings available as the capital gain on the stock is avoidable and the donor receives a charitable deduction.

In addition, a qualified charitable deduction allows an individual to transfer up to \$100,000 from an Ira directly to a qualified charity. It is only available to IRAs and individuals who have reached RMD age (70.5). Any amount processed as a Qualified Charitable Deduction counts toward your RMD requirement and reduces the taxable amount of your IRA distribution. This lowers both your adjusted gross income and taxable income, resulting in a lower overall tax liability.

The Benton Harbor Soup Kitchen accepts donations of individual stock or distributions from an IRA. We appreciate all the gifts we have received in the past and our so thankful for the financial support we receive from our local community, without these generous donations it would be very difficult for the Soup Kitchen to carry out our mission of serving the less fortunate.
